

Sub: Filling up of the one (01) post of Upper Division Clerk-Cashier in **Level-4 (Rs. 25,500-81100) in Grade Pay of Rs. 2400/-** in ATI-EPI, Dehradun under the Directorate General of Training(DGT), Ministry of Skill Development & Entrepreneurship through deputation basis a subordinate office.

It is proposed to fill up one (01) post of Upper Division Clerk-Cashier **Level-4 (Rs. 25,500-81100)) in Grade Pay of Rs. 2400/-** in ATI-EPI, Dehradun, Directorate General of Training(DGT), Ministry of Skill Development & Entrepreneurship on deputation basis . The eligibility for appointment to the post will be as follows:-

1. LDC/UDC/Cashier under the Central Government Office:-

- (a) (i) Holding analogous post on regular basis in the parent cadre or department:
or
(ii) Holding the post of Lower Division Clerk with eight years regular service in the grade on a regular basis.

Note:


The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation Similarly deputationists shall not be eligible for consideration for appointment by promotion. (period of deputation including the period of deputation in another excadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment be deputation shall not exceed 56 years as on the closing date of receipt of application)

3 It is requested that the application (in-duplicate) in the enclosed proforma(Annexure) in respect of the officer(s) who could be spared in the event of their selection may be forwarded to The Director, ATI-EPI-Dehradun at the above mentioned address on or before 29th June 2018. The application must be forwarded through proper channel and must accompany the following documents/information;

- (i) A certificate that no disciplinary proceedings/vigilance case is either pending or contemplated and a certificate to the effect that no major/minor penalties were imposed on him during last 10 years.
- (ii) Complete and up to date ACRs/APARs(in original) from 2013-2014 to 2017-2018 (If original is not readily available, photocopies of the same duly attested by an officer not below the rank of Under Secretary to the Govt. of India).
- (iii) Integrity Certificate.
- (iv) Cadre Clearance Certificate.

Applications received incomplete and after the last date and otherwise without the above documents/information will not be entertained. The candidates, who apply for the post will not be allowed to withdraw their candidature subsequently.
